- 1. **Election of chair for this meeting:** Cllr R brooks was elected to preside over this meeting.
- **2. Declaration of interests:** Cllr J Boyt item 6
- 3. Apologies: Cllr A Colley
- 4. Minutes of the previous meeting to be adopted and signed by the residing chair. Approved and signed.
- 5. Adjournment and welcome to the public. (Max 3 mins per question, 20 minutes in total) for questions from residents in attendance. Ten residents in attendance. Two residents commented on the recent flooding in High Street during Storm Henk and said that their email alert arrived post event, but they were grateful for assistance the received with sandbags, road closure, and said that they were fortunate as the flood water did not enter their house. Councillors said that it would be useful to have a stock of sand available for the future, batteries for torches and that the rake should be accessible to keep the debris screen clear and mentioned that bow waves from passing traffic could force water into adjacent properties. It is also essential that High Street residents ensure that they have current phone numbers registered with the flood working group, in order to receive flood alerts from the flood monitoring device up stream.
- **6. Planning applications:** PL/2023/10332 Potterne solar farm, an application to build a solar farm and the associated infrastructure covering over two hundred acres of agricultural land for fifty years. There was considerable discussion between councillors and residents regarding the pros and cons of the proposed solar farm. It was noted that there were numerous errors in the application which appeared to have copied and pasted from another application in another county. Residents and concerned citizens were urged to make their own comments online before the consultee deadline of 1st February. Councillors resolved to object to the planning application.
- **7. Update from Wiltshire Councillor Dominic Muns** Cllr Muns informed councillors and residents of an update re: Black dog junction, the owners of

Black Dog farm have declined to sell any of their land or relocate fencing to improve the sightlines for Black Dog junction. Wiltshire Council will have to consider other options for improving the junction's safety. A Devizes area board meeting will be held on 26th February, with a bias on Highways. A planning application has been received for a new Co-op shop and several houses in Market Lavington, a survey conducted by the Co-op indicated that 78 percent of respondents were supportive. The governments five-year housing supply target has been reduced to a four-year housing target and Wiltshire Council has exceeded the target, so the planning inspectorate should not be able to force acceptance of planning applications for more housing.
